Please note as per March 2023 HS code is required for all shipments to or transiting the EU. The EORI number of the consignee in the EU is mandatory too.

- For flights the AWB/HAWB details are always needed when the off point is within the EU.
- For trucks the AWB/HAWB details are not needed when the origin is an EVA country and the destination country does not have pre-arrival customs requirements.
- For EU-EU traffic AWB/HAWB details are not needed.
- "For this purpose taken as part of EU", we need AWB/HAWB details because AMS or CDG are always used as transit station to these countries.

When the final destination lies in a country without custom requirements it is still possible custom requirements are applicable because of the transit station. The EU and US require the same data for transit shipments as shipments destined for that particular country.
